

## **Requirements for visitors with pre-approved and on-arrival visas**

### **Visa Types: Family (Yearly visit), Owner of Real Estate, Student and Medical**

#### **1. Standard Health Measures**

##### **Fully Vaccinated / Recovered**

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 PCR Test Required Before Traveling to Qatar – Required for 12 years and above age
- Optional if traveler is a resident of a GCC country, or an EU national/resident provided their immunity status is visible in above-mentioned APPS.
- All others, mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
- Type & Duration of Quarantine - Exempted from quarantine
- COVID-19 Test Required on Arrival in Qatar
- If a resident of GCC country or an EU national/resident who does not have a pre-travel PCR, the traveler must proceed to any authorized private clinics for Rapid Antigen test within 24hrs of arrival; otherwise, not applicable.

##### **Unvaccinated / Non-Immune**

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
- Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
- Type & Duration of Quarantine - 5 days Hotel, or Home quarantine for those with first-degree relatives (Home quarantine applicable only for family yearly visit visa provided this is as per the Ehteraz approval)
- COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 5 of Hotel/Home quarantine

#### **2. Red Health Measures Fully Vaccinated / Recovered**

- Ehteraz Pre-registration and approval – Required



### Various Qatar Visa Types

- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
  - COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
  - Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
  - Type & Duration of Quarantine – 1 day Hotel quarantine
  - COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 1 of hotel quarantine
- Unvaccinated / Non-Immune:
- Ehteraz Pre-registration and approval – Required
  - COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
  - Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
  - Type & Duration of Quarantine - 5 days Hotel, or Home quarantine for those with first-degree relatives (Home quarantine applicable only for family yearly visit visa provided this is as per the Ehteraz approval)
  - COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 5 of hotel quarantine

### **Visa Types: High Level Executives, Those accompanying GCC nationals, Work, Temporary work, Seamen, Government, Official Conference, Sports**

#### **1. Standard Health Measures**

##### Fully Vaccinated / Recovered

- Ehteraz Pre-registration and approval – Required
- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
- COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age



### Various Qatar Visa Types

- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
  - Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
  - Type & Duration of Quarantine - Exempted from quarantine
  - COVID-19 Test Required on Arrival in Qatar
  - If a resident of GCC country or an EU national/resident who does not have a pre-travel PCR, the traveler must proceed to any authorized private clinics for Rapid Antigen test within 24hrs of arrival; otherwise, not applicable.
- Unvaccinated / Non-Immune
- Ehteraz Pre-registration and approval – Required
  - COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
  - Type & Duration of Quarantine - 5 days Hotel Quarantine Required
  - COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 5 of Hotel/Home quarantine

### 2. Red Health Measures Fully Vaccinated / Recovered

- Ehteraz Pre-registration and approval – Required
  - Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
  - COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
  - Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
  - Type & Duration of Quarantine – 1 day Hotel quarantine
  - COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 1 of hotel quarantine
- Unvaccinated / Non-Immune:
- Ehteraz Pre-registration and approval – Required
  - COVID-19 Test Required Before Traveling to Qatar– Required for 12 years and above age



## Various Qatar Visa Types

- Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
- Type & Duration of Quarantine - 5 days Hotel Quarantine Required
- COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 5 of hotel quarantine

### Visa Type: New Born

#### 1. Standard Health Measures

##### Fully Vaccinated / Recovered

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 Test Required Before Traveling to Qatar – Not Required
- Type & Duration of Quarantine - As per accompanying parent
- COVID-19 Test Required on Arrival in Qatar – Not Required

##### Unvaccinated / Non-Immune

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 Test Required Before Traveling to Qatar – Not Required
- Type & Duration of Quarantine – As per accompanying parent
- COVID-19 Test Required on Arrival in Qatar – Not Required

#### 2. Red Health Measures Fully Vaccinated / Recovered

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 Test Required Before Traveling to Qatar – Not Required
- Type & Duration of Quarantine – As per accompanying parent
- COVID-19 Test Required on Arrival in Qatar – Not Required

##### Unvaccinated / Non-Immune:

- Ehteraz Pre-registration and approval – Not Required
- COVID-19 Test Required Before Traveling to Qatar – Not Required
- Type & Duration of Quarantine – As per accompanying parent
- COVID-19 Test Required on Arrival in Qatar – Not Required

### Visa Types: Family (Short term), Business, GCC residents visa on arrival, Pre-arranged Tourist Visa, Visa on Arrival and Personal visa

#### 1. Standard Health Measures

##### Fully Vaccinated / Recovered



### Various Qatar Visa Types

- Ehteraz Pre-registration and approval – Required
- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
- COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.
- Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
- Type & Duration of Quarantine - Exempted from quarantine
- COVID-19 Test Required on Arrival in Qatar
- If a resident of GCC country or an EU national/resident who does not have a pre-travel PCR, the traveler must proceed to any authorized private clinics for Rapid Antigen test within 24hrs of arrival; otherwise, not applicable.

#### Unvaccinated / Non-Immune

- Ehteraz Pre-registration and approval – Required
- COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
- Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
- Type & Duration of Quarantine - 5 days Hotel Quarantine required
- COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 5 of Hotel/Home quarantine
- \*\*Family (short term) and Personal visa type holders must have insurance to cover medical expenses during their stay in Qatar

## 2. Red Health Measures Fully Vaccinated / Recovered

- Ehteraz Pre-registration and approval – Required
- Optional if traveler is a resident of a GCC country, or an EU national/resident with their immunity status visible in above mentioned APPS.



### **Various Qatar Visa Types**

- COVID-19 Test Required Before Traveling to Qatar – Required for 12 years and above age
  - Mandatory to submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin
  - Type & Duration of Quarantine – 1 day Hotel quarantine
  - COVID-19 Test Required on Arrival in Qatar - Rapid Antigen Test on day 1 of hotel quarantine
- Unvaccinated / Non-Immune:
