

EXCESS VALUE DECLARATION (Article 22.2 of the Montreal Convention)

Please fill this Excess Value Declaration form detailing the item of checked Baggage that you wish to cover to a higher increase the applicable liability limits stated in Article 16 III (iii) (b) of Qatar Airways Conditions of Carriage in the event of loss or damage to a maximum value of USD 2500 per passenger. Contact the nearest Qatar Airways office or call us at number specified on qatarairways.com/help prior to check-in to pay the supplementary fee of Excess Value Declaration which will increase the Qatar Airways' liability limits to the declared value but will not exceed the maximum amount of USD 2500 per passenger. **Value declaration for carry-on baggage shall not be accepted.** At the check-in desk, you must handover this form and inform the check-in agent that the excess value of your baggage was declared and show the payment receipt.

If you would like to submit an Excess Value Declaration, please complete the table on the reverse as accurately as possible. Don't forget to list all items you are carrying, plus the outer container(s) (suitcase, travel bag, etc.).

THE DECLARATION OF HIGHER VALUE IS NOT ALLOWED FOR ALL ITEMS THAT ARE EXCLUDED FROM THE LIABILITY IN THE QATAR AIRWAYS' GENERAL CONDITIONS OF CARRIAGE OR WHICH ARE FORBIDDEN AS CHECKED BAGGAGE (AND ITS CONTENTS).

The following terms and conditions apply:

1. Excess Value Declarations may only be submitted and are only applicable for Qatar Airways operated flights and where your ticket is issued on Qatar Airways ticket number (157).
2. We will refuse to accept an excess value declaration on Checked Baggage when a portion of the carriage is/was to be provided by another Carrier.
3. Qatar Airways reserves the right to check the declared items prior to departure.
4. In the event of baggage through check-in by other airline on our operating flights, we will refuse to accept an excess value declaration on Checked Baggage.
5. Excess Value Declaration is valid for one continuous flight journey in one direction, including transfer(s) but not including any stopover(s) between the individual legs. If you wish to have coverage for other portions of your journey, you will need to submit separate declarations and pay the applicable supplementary fee of Excess Value Declaration accordingly.
6. Please keep copy of the completed form with you throughout your entire journey. In the event of damages, please indicate that you have submitted an Excess Value Declaration.
7. For each Excess Value Declaration a supplementary fee of 5% of the excess declared value will be levied prior to travel. Declaration values must be greater than 1288 SDR but shall not exceed USD 2500. The supplementary fee is non-refundable.
8. The Qatar Airways Conditions of Carriage for Passengers and Baggage, as well as any applicable government regulation apply.

The liability of carrier for Checked Baggage where an excess value declaration is made and supplementary fee paid, is capped to the value declared subject to proof of any loss, pilferage or damage, but will not exceed the maximum amount of USD 2500.

Qatar Airways is not liable for loss or damage due to:

- defective baggage, improper packing or closure,
- carriage in checked baggage of perishable and/or fragile items,
- normal wear and tear,
- for damage caused by or connected with security checks performed or ordered by government authorities,
- further restrictions as specified in the Qatar Airways Conditions of Carriage.

In the event of loss or damage, you will need to provide proof of the value of the loss (purchase receipt) for every single item. Qatar Airways will reimburse the costs of repair for the affected items or if the items are irreparable, the fair market value of the items up to the amount stated in the Excess Value Declaration. The fair market value shall be the replacement cost of the items minus consideration for normal wear and depreciation.
